2. To coordinate (Associate) Subject Leaders in the design, planning, coordination, quality assurance, monitoring and evaluation of the curriculum, ensuring that it meets the aims of the school, the needs of all pupils, and ensuring that it meets the aims of the school and National Curriculum.
3. To lead quality assurance and teacher development to ensure that teachers:
 - Teach consistently high-quality lessons informed by the school's teaching principles
 - Set expectations for students in relation to standards of achievement and the quality of learning and teaching
 - Teach to ensure knowledge is retained in long term memory of students
 - Assess and adapt teaching to the strengths, weaknesses and misconceptions of classes
 - Follow the faculty feedback policy, providing formative feedback in every lesson and whole class feedback for set pieces of work
 - To maintain discipline in accordance with the school procedures, and to encourage good practice with regard to punctuality, behaviour, standards of work and homework
 - Work in collaboration with Learning Support Assistants, Special Educational Needs, EAL Team and Deaf Support Base staff attached to any teaching group, ensuring that appropriate approaches to learning are used in relation to pupils with specific learning needs
 - Follow the school policies and procedures
4. To provide regular feedback for subject colleagues in a way which recognises good practice and supports their progress against performance management objectives resulting in tangible impact on student learning.
5. To ensure all subject staff understand, and are actively implementing, the key aspects of the school's behaviour and inclusion policies.

Leadership of faculty

1. Assisting in the recruitment of faculty staff in accordance with the DfE's Safer Recruitment in Education guidelines and the school's Recruitment policy.
2. Leading on induction, guidance and advice for faculty staff.
3. Determining roles and responsibilities within the faculty in liaison with the SLT line manager, and leading and managing the Subject Leaders and Subject Drivers in the Faculty.
4. Writing a Faculty Development Plan which dovetails with the School Development Plan and which lays out strategies for improving student progress at KS3 KS4 and KS5 within the Faculty.
5. Reviewing progress towards targets and outcomes laid out in the FIDP and to amend the plan accordingly.
6. Ensuring efficient communication within the faculty, leading faculty planning and development time and line management meetings.
7. Overseeing the organisation of student groups and the allocation of staff to classes to ensure maximum student progress.
8. Managing the Performance Management process for staff in the faculty.
9. Creating an environment where there is visible acknowledgement that everyone's contribution is valued.
10. To develop the unique culture and identity of the Faculty and to be an ambassador for it within the school and the wider community.
11. To promote strong working relationships between all colleagues, and to facilitate positive relationships between students and staff in the Faculty.

Coaching and Mentoring

1. To coach and mentor staff to become more effective teachers
2. To support the induction of NQTs and with Initial Teacher Training
3. To take a lead role in leading and supporting the CPD of colleagues who require additional support and guidance
4. To be coached and model a positive attitude to continuous teacher development

Finance and resources

3. Plan teaching in accordance with faculty schemes of work and National Curriculum programmes of study.
4. Liaise with relevant colleagues on the planning of units of work for collaborative delivery.
5. Teach consistently high-quality lessons informed by the school's teaching principles.
6. Set expectations for students in relation to standards of achievement and the quality of learning and teaching.
7. Teach to ensure knowledge is retained in long term memory of students.
8. Assess and adapt teaching to the strengths, weaknesses and misconceptions of classes.
9. Follow the faculty feedback policy, providing formative feedback in every lesson and whole class feedback for set pieces of work.
10. To maintain discipline in accordance with the school procedures, and to encourage good practice with regard to punctuality, behaviour, standards of work and homework.

11. Work in collaboration with Learning Support Assistants, Special Educational Needs Team and Inclusion Team.
12. Be familiar with the SEND Code of Practice for identification and assessment of Special Educational Needs and keep appropriate records on Individual Education Plans for students.
13. Be a role model for students, inspiring them to be actively interested in your subject.
14. Updating professional knowledge and expertise as appropriate to keep up to date with developments in teaching practice and methodology, in general, and in your curriculum area.
15. Promote learning through out-of-hours activities such as enrichment, educational trips and speaker visits.
16. Promote aspects of Personal Development, CEIAG and enrichment related to your subject.
17. To understand progression and be able to assess against benchmarks, and to keep such records as are required.
18. To be comfortable using data to plan interventions for individual students.
19. To provide, or contribute to, oral and written assessments, reports and references relating to individual students and groups of students.
20. Undertake assessment of students as requested by external examination bodies, curriculum areas and school procedures.
21. To follow the school policies and procedures on teaching, learning and assessment.

Staff Development

1. To continue personal development in the relevant areas including subject knowledge and teaching methods.
2. To engage actively in the Performance Management process.
3. Participate in whole school and CPL programmes.

Student Support and Progress

1. To be a Form Tutor to an assigned group of students if and when required.
2. To promote the general progress and well-being of individual students and the Tutor Group as a whole.
3. To liaise with the relevant pastoral leaders to ensure the implementation of the Student Support system.
4. To register students, accompany them to assemblies, encourage their full attendance at all lessons and their participation in other aspects of school life.
5. To evaluate and monitor the progress of students and keep up-to-date student records as may be required.
6. To contribute to the preparation of Action Plans and other reports as required.
7. To alert the appropriate staff to problems experienced by students.
8. To communicate as appropriate, with the parents of students and with persons or bodies outside the school concerned with the welfare of individual students, after consultation with the appropriate staff.
9. To contribute to personal development, CEIAG and enrichment according to school policy.
10. To apply the Behaviour for Learning policy so that effective learning can take place.
11. Meet with students over whom there are concerns and contact home where necessary in conjunction with student support teams.
12. Meet with students over whom there are concerns and contact home where necessary in conjunction with student support team and faculty heads.

Training
